The A.v. Peptide Antibody recognizes wild-type GFP, EBFP, ECFP, EGFP, EYFP, AcGFP, and both N- and C-terminal fusion proteins containing these GFP variants in bacterial and mammalian cell lysates.

### QUALITY CONTROL DATA

The quality and performance of this lot of Living Colors A.v. Peptide Antibody was tested by Western blot analysis using lysate made from an HEK 293 cell line stably expressing AcGFP1. After cells were collected and lysed using SDS sample buffer, the lysate (10 µl; equivalent to 35,000 cells) was electrophoresed on a 12% SDS-polyacrylamide gel and transferred to a nitrocellulose membrane. The blot was probed with the Living Colors A.v. Peptide Antibody (diluted 1:400), followed by a secondary goat anti-rabbit antibody conjugated to horseradish peroxidase (HRP). The HRP signal was detected by chemiluminescence. A band of approximately 30 kDa corresponding to AcGFP1 was observed in the lane loaded with the AcGFP1 cell lysate. A band of this size was not detected in the lysate of untransfected HEK 293 cells.
