MCF7 Tet-Off Advanced is a human breast adenocarcinoma (pleural effusion)-derived cell line that expresses the tetracycline (Tet)-regulated transactivator Tet-Off Advanced. Inducible expression of any gene can be achieved by transfecting or transducing this cell line with a vector containing your gene of interest under the control of a tetracycline-responsive promoter. Expression is induced by the withdrawal of doxycycline (Dox) from the culture medium. Tet-inducible cell lines are shipped with Tet System Approved FBS and a control cell line created for inducible expression of luciferase.
