## **Quality Control Data**

The Capturem Maxiprep Protein G Maxiprep Columns were tested using mouse serum and the buffers described in the Capturem Protein G Maxiprep Protocol-At-A-Glance. A serum sample was diluted 1:15 with Equilibration/Binding/Wash Buffer. The column was then equilibrated with 6 ml of Equilibration/Binding/Wash Buffer, centrifuged at 2,000g for 3 min, and loaded with 20 ml of pre-diluted serum. After centrifugation at 2,000g for 3 min, the column was washed with 6 ml of Equilibration/Binding/Wash Buffer and centrifuged. Bound antibody was then eluted twice with 1.5 ml Elution Buffer, each time into a tube containing 150 µl of Neutralization Buffer. The combined eluates were analyzed by electrophoresis on a 4–20% SDS polyacrylamide gel to verify the purity of the eluted antibodies. The expected ~25 kDa band (corresponding to light chain IgG) and ~50 kDa band (corresponding to heavy chain IgG) were observed.
