Antibody:

Monoclonal antibody was produced from the established hybridoma obtained by fusing the mouse myeloma cell line P3U1 with spleen cells of BALB/c mouse after immunization with human procollagen type I C-peptide(PIP) purified from human fibroblast cell culture supernatant. The monoclonal antibody was harvested from ascitic fluid.

Bovine Serum Albumin (BSA):

Manufactured from the plasma of animals of 100% Australian origin that have undergone veterinary anteand post-mortem inspection.

Quality Control:

The lyophilized antibody was dissolved in $50 \mu l$ of the supplied Reconstitution Solution. The antibody dilutions were applied for ELISA assay by colorimetric detection using a microtiter plate immobilized with PIP from human cell culture serum free supernatant. The expected antibody titeration was obtained.

Manufacturing Control:

<u>Purification</u>: Antibody was purified by ammonium sulfate precipitation and column chromatography from mouse ascites. The antibody was dissolved in 10 mM PBS, pH7.4, containing 1.0% bovine serum albumin, and then lyophilized.

<u>BSA treatment</u>: Process performed to inactivate pathogenic viral agents: The BSA was manufactured using temperatures in excess of 65°C and pHs <5.0.
