All primers were functionally tested with 200 pg of 200-bp sheared human genomic DNA using the ThruPLEX® DNA-Seq Kit to produce indexed libraries. The libraries were pooled, purified, quantified, and then sequenced on the Illumina sequencing platform. The following parameters were measured for libraries prepared with indexed primers, which were required to meet the following specifications:
