Quality Control Data

All primers were verified by ESI analysis to have a major peak with a measured molecular weight within 10 Da of the predicted molecular weight.

All primers were functionally tested with first-strand cDNA generated with reagents obtained from the SMARTer® Stranded Total RNA-Seq Kit v2 - Pico Input Mammalian. The libraries were purified, quantified, and verified to generate a uniform yield across all the primers ($CV \leq 20\%$) with no primers generating a library yield 40% above or below the average yield of all libraries. Following quality assessment by quantification, libraries were pooled and then sequenced on an Illumina sequencing platform, generating uniform representation of all the barcodes ($CV \leq 25\%$).
